
#### Comments concerning proposed rulemakings

On page 7 (f 23) of "Proposed New 16 AC 3.63 and Proposed Amendments to 3.107 to Implement HB 3648 and SB3", a gas facility can file for an exemption (exempting a facility from winterizing their equipment) at a filing cost of \$150. This is a stupid rule that should NOT be implemented. 1) \$150 is a tiny expense for a company to avoid important (albeit, expensive) costs toward winterizing their equipment. 2) I see that if the exemption is approved, then the company can add further equipment to the exemption WITHOUT incurred any more filing costs. Gee, get an exemption for 1 gas valve and expand it for an entire plant at no additional cost! Rather than allow gas companies to file for this exemption, how about these companies come before the Railroad Commission (in an open meeting) and present a detailed lecture as to why they can't possibly winterize their equipment... AND if their excuse is "It will cost too much" then make this EXEMPTION filing cost some large percentage of the "winterization cost": like 10 percent of the winterization cost. But I understand that the Railroad Commission does not have the power to ALTER this "\$150" exemption" rule; that is up to the Texas Legislature. Still, your asking for my comment on the rule so I assume you have the authority to "drop the exemption rule" entirely. That would be my

recommendation. NO EXEMPTIONS for winterization of gas facilities/equipment. And if the gas companies are upset about that, then the can talk to the Texas Legislature.
