Objections are considered received by the Railroad Commission of Texas on the day of actual receipt-NOT on the day of mailing.** You may state any objections on this form; however, you must make a proper objection for it to be considered. Under Section 9.103, a proper objection to a proposed installation must include a statement alleging either (A), (B), or (C) below, and contain supporting facts. Please check the applicable statement below and provide supporting facts or any comments on Page 2 of this form.

- _____ (A) I object on the basis of noncompliance with the *LP-Gas Safety Rules*, with reference to the particular rule(s) relied upon.
- _____ (B) I object on the basis of noncompliance with the statutes of the State of Texas, with reference to the particular provision relied upon.
