8. Eligibility

Eligibility for the VCP is described in 16 TAC §§ 4.405 and 4.410 and summarized below:

- (a) VCP eligibility applies to any substance defined in 16 TAC § 4.405(8) as a waste, pollutant, or other substance or material regulated by or that results from an activity under the jurisdiction of the Commission under Texas Natural Resources Code, Chapters 91 or 141, or the Texas Water Code. Further clarification on jurisdiction can be found in 16 TAC § 3.30, Memorandum of Understanding between the Railroad Commission of Texas and the Texas Commission on Environmental Quality.
- (b) Eligibility for participation in the VCP is restricted to the portion of a site that is not subject to a Commission order to control or clean up the contaminants.
- (c) Any person who is not a responsible person is an eligible applicant as defined in 16 TAC § 4.405(10, 13) and may participate in the Voluntary Cleanup Program. Responsibility does not extend to third parties or landowners who did not cause or contribute to contamination.

10. Intent to Participate

The undersigned requests that the RRC oversee the investigation and remediation activities of possible contamination at the property described above and intends to negotiate, in good faith, a written agreement with the RRC to provide technical and regulatory oversight for the investigation and remediation. This Intent to Participate does not constitute such an agreement and neither RRC nor the undersigned will be bound to proceed with VCP oversight unless such an agreement is executed and appended to this application.

Applicants should be aware that in order for the RRC to issue a VCP Certificate of Completion for the entire Site as it is currently described in this application or will be described at the time of certificate issuance in a metes and bounds legal description of the property, the Applicant must provide adequate information to document that the entire Site meets the remediation standards to which the Applicant and RRC will agree in a VCP Agreement, if such an agreement is executed. The VCP Agreement will describe the project activities of each party and will require Applicant A (unless indicated otherwise on page 2 of this form) to reimburse the RRC for all of its oversight costs. By completing and signing this Intent to Participate, all environmental media that exceed applicable protective concentration levels shall be addressed through response actions to which the Applicant and RRC agree.

The undersigned affirms that the Applicant is financially capable of performing the entire voluntary cleanup to which the Applicant agrees. The undersigned also affirms that the Applicant is not a Responsible Person as defined in 16 TAC § 4.405 and is otherwise eligible to participate in the VCP as per 16 TAC § 4.410 and Texas Natural Resource Code § 91.653. The Commission may request additional information to support these affirmations.

With this Intent to Participate, the undersigned does not admit or assume liability for investigation or cleanup of the Site. In addition, the undersigned may terminate the Intent to Participate at any time. If the RRC rejects the application, it will notify the Applicant, within 45 days, explain the reasons for rejection, and will refund half of the application deposit, unless the Applicant indicates a desire to resubmit a corrected application. An applicant can resubmit a rejected application once, without submitting an additional application fee, if the application is resubmitted within 45 days of the date of the notice of rejection.

11. Financial Capability

Deposit of Oversight Costs

The Applicant must submit with this application, a deposit in the amount of one thousand dollars (\$1,000), made payable to the Railroad Commission of Texas. Be aware that a non-refundable surcharge of (\$1,500) is also required at the time the application is submitted. Deposits may be made in the form of company or personal checks. If a deposit check is returned due to insufficient funds, the application will be considered incomplete and will be rejected. Cash deposits will not be accepted.
